SUBJECT: Amendment to the 2018-2019 Wabigoon Forest Contingency Plan

This letter is to notify you that the Dryden District of the Ontario Ministry of Natural Resources and Forestry (MNRF) has received a request from Domtar Inc. to amend the *2018-2019 Contingency Plan for the Wabigoon Forest* to allow for the construction of branch and operational roads. This amendment provides for the addition of road corridors to accommodate required road construction during the *2018-2019 Wabigoon Forest Contingency Plan* to prepare for harvest allocations being planned for the *2019-2029 Wabigoon Forest Management Plan*.

Road construction will occur off the following roads; Suzanne Road, Melgund Lake Road, Bear Narrows Road, Barren Brook Road, and Moon Lake Road in the areas of Suzanne Lake, Avery Lake, Straight Lake, Weiseieno Lake and Bunyan Lake. Please refer to the enclosed map for more detail. (*stars show the approximate area of interest*).

A fifteen (15) day public review period from **June 20, 2018** to **July 4, 2018** for the proposed amendment is being provided to all interested parties. The plan will be posted to the www.ontario.ca/forestplans on **June 20, 2018** and any comments and/or concerns will need to be received before or on **July 4, 2018**. 

However, this information may be used by the MNRF as public input on other resource management surveys and projects. 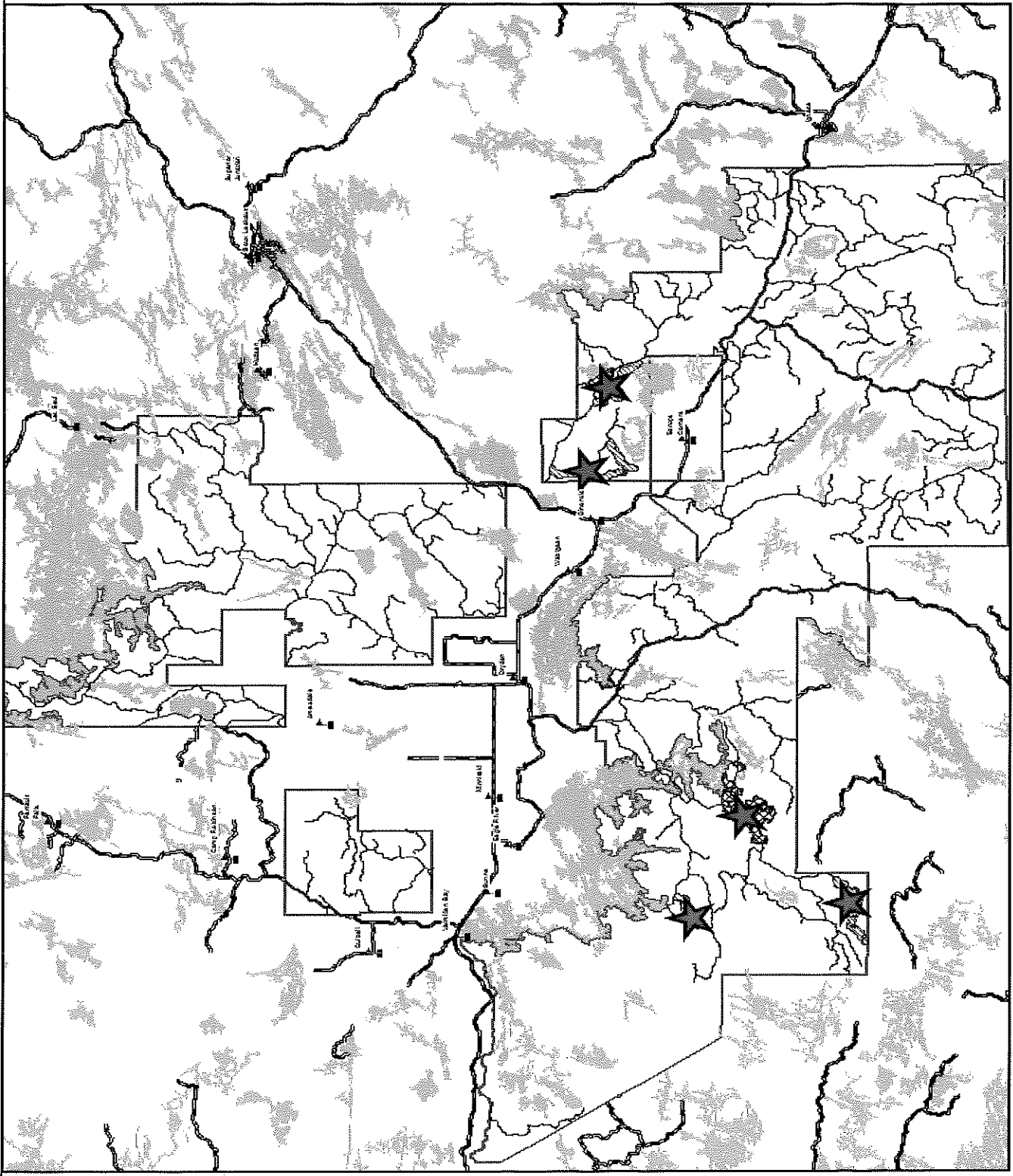
