- 1. Conduct a self-assessment

- 3. Post all necessary info
- 4. Assess & manage risks
- 5. Establish H&S Rep/JHSC
- 6. Train staff
- 7. Document your program

- Plan for the future





The Ministry of Labour is seeking input on a proposed regulation that would make specific training mandatory for all workplaces covered under the Occupational Health and Safety Act. The first training to be specified: health and safety awareness for workers and supervisors. Other types of mandatory training would follow.
